#### Statement of Intent

At the Newman Catholic Trust, we are committed to environmental stewardship rooted in the Catholic principle of caring for God's creation. Guided by Pope Francis' Laudato Si', we recognise our moral and social responsibility to address the environmental challenges of our time. Our schools aim to educate pupils about sustainability and climate change through practical experiences, embedding a sense of responsibility for their local surroundings and the global environment.

By implementing this policy, we will:

- Promote sustainable living practices within our school communities.
- Minimise our carbon footprint and environmental impact.
- Prepare our pupils to be active global citizens who can tackle the challenges of a changing climate.

# 1. Legal Framework

This policy aligns with the following legislation and guidance:

- Environmental Protection Act 1990

- DfE (2022) Sustainability and Climate Change Strategy
- UN Sustainable Development Goals (SDGs)

#### 2. Roles and Responsibilities

#### Trust Leadership

- Develop and maintain a unified Trust-wide strategy for sustainability.
- Allocate resources for environmental initiatives across schools.
- Monitor compliance with this policy and set measurable targets.

#### **CEO**

- Ensure Trust schools have the tools, training, and resources to embed sustainability.
- Promote partnerships with external organisations to enhance sustainability efforts.

#### **Principals**

- Lead their schools in implementing this policy effectively.
- Facilitate training and awareness sessions for staff and pupils on sustainable practices.
- Monitor energy usage, waste management, and procurement for sustainability.

# Local Governing Committees (LGCs)

Oversee schools' environmental performance.

- Assess the sustainability credentials of contractors and suppliers.
- Support funding applications for eco-projects, such as renewable energy or biodiversity initiatives.

#### Staff

- Incorporate sustainability into lessons and day-to-day practices.
- Encourage pupils to participate in environmental initiatives.
- Lead by example in conserving resources such as energy and water.

#### **Pupils**

- Actively participate in eco-initiatives, such as litter picks or recycling programmes.
- Apply sustainable practices at home and in their local communities.

# **Parents and Guardians**

- Reinforce the importance of sustainability at home.
- Encourage walking, cycling, or carpooling to reduce transport emissions.

#### 3. Waste and Recycling

We commit to reducing waste by:

- Minimising paper usage through digital communication and resource sharing.
- Setting up well-labelled recycling points for paper, plastics, glass, and food waste.
- Promoting reusable items, such as water bottles and lunch containers.
- Composting food waste for use in school gardens.
- Engaging pupils in waste audits and campaigns to reduce landfill waste.

# 4. Waste Electrical and Electronic Equipment (WEEE)

We will responsibly dispose of all electrical equipment by:

- Partnering with recyclers or organisations that refurbish and donate devices.
- Ensuring data on disposed equipment is securely erased in line with data protection laws.
- Conducting regular audits to identify reusable or repairable items.

#### 5. Littering

Littering is unacceptable on school premises and in the surrounding community.

- Schools will organise regular litter-picking events and promote anti-littering campaigns.
- All waste will be disposed of responsibly in appropriate bins located throughout school grounds.
- Pupils will learn about the harmful effects of litter on biodiversity in science and PSHE lessons.

#### 6. Transport

We will reduce transport emissions by:

- Encouraging walking, cycling, and carpooling.
- Providing secure bike storage and road safety education.
- Exploring options for electric or hybrid school transport where applicable.

#### 7. School Grounds and Biodiversity

We will enhance school grounds to:

- Promote biodiversity through planting native trees, wildflowers, and creating habitats such as bug hotels and ponds.
- Provide outdoor learning spaces that connect pupils with nature.
- Use eco-friendly materials for landscaping and outdoor furniture.

# 8. Healthy Living and Wellbeing

- Teach pupils about the connections between healthy lifestyles and sustainability.
- Encourage active outdoor activities that benefit both health and the environment.
- Promote sustainable food choices in school meals, including local and seasonal produce.

## 9. Energy Management and Carbon Reduction

We commit to reducing energy use and emissions by:

- Transitioning to renewable energy sources where possible.
- Upgrading to energy-efficient lighting and heating systems.
- Implementing energy-saving measures, such as motion-sensitive lighting and insulation.
- Displaying energy usage data in schools to encourage awareness.

## 10. Curriculum Integration

Environmental sustainability will be embedded across the curriculum:

- Catholic Social Teaching: Responsibility to care for God's creation.
- Science: Understanding climate change, biodiversity, and renewable energy.
- Geography: Exploring environmental challenges and sustainable solutions.
- **PSHE:** Discussing the impact of lifestyle choices on the environment.

Cross-curricular projects, such as eco-gardens or climate action plans, will engage pupils in hands-on sustainability efforts.

#### 11. Monitoring, Review, and Reporting

• This policy will be reviewed annually by the CEO and the Trust Board, with input from staff and pupils.
